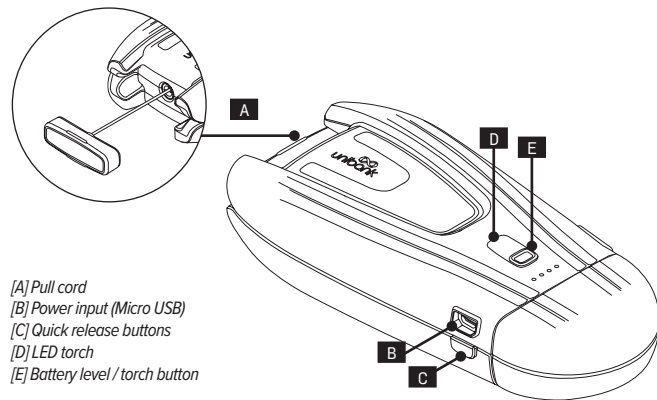

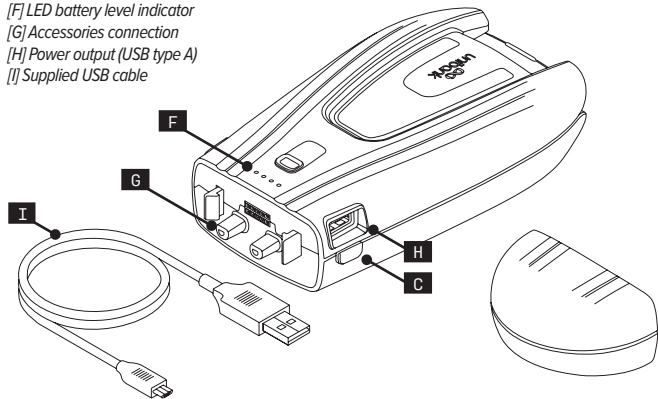

Product diagram

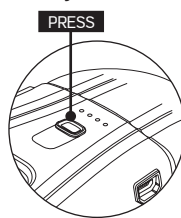


- [A] Pull cord

System requirements

The Unibank™ Power bank requires a smartphone to check the battery level and use the attachments.

- Apple iOS devices: Requires iOS 10 or newer
- Android devices: Requires Android 5.0 (Lollipop) or newer

Device maintenance and care

- Fully charge the UNIBANK before first use optimise battery life
- Keep away from liquids, extreme heat and fire. Do not penetrate or otherwise damage the battery
- Store in a cool, dry place
- Do not use or store in humid environments
- Operating temperature should be between 0°C and 45°C
- Avoid severe drops, bumps and abrasions
- Do not clean the product with harmful chemicals
- Do not use the product in enclosed or unventilated environments, such as from within a bag or pocket. This could cause overheating
- Stop using the product immediately if it becomes very hot, emits an odour or becomes deformed or broken

- Charge at least once every 2-3months to avoid complete battery depletion
